

# THE DANGERS OF DETENTION: USING RESEARCH TO PREVENT OR LIMIT JUVENILE INCARCERATION

Detention is not benign. It has significant short- and long-term effects on the case and the young person you represent. The following is a small sampling of the research you can use to prevent detention or defeat a disposition involving secure confinement, as well as to educate the courts, policymakers, and the public.
